- REHOMING OF LIVESTOCK

We do not seek payment for the livestock to be rehomed.

Applications for animals will be assessed for suitability by Rockhampton Regional Council ("Council") on a 'first come, first served' basis. Council, in their complete discretion may deem applications unsuitable, in which case, the application next in time will be assessed.

Application to acquire an animal, and notification from Council that you have been successful in your application to acquire an animal does not imply ownership of, or any right to the animal. Ownership and all other rights and responsibilities related to the animal will transfer from Council to the successful applicant upon their signing of the Conditions of Acquisition when collecting, at their expense, the animal from the Rockhampton Heritage Village.

Upon receiving written notice from Council that they are successful in their application for an animal ("the Notice"), the successful applicant will have 30 days to collect the animal from the Rockhampton Heritage Village. If the successful applicant does not collect the animal from the Rockhampton Heritage Village within 30 days from the Notice, Council may, in its complete discretion select the next suitable applicant to acquire the animal.

By acquiring an animal from Rockhampton Regional Council ("Council"), the person acquiring the animal ("the Acquirer") will sign the Conditions of Acquisition and agree:

- (1) to take ownership of, and accept all rights and responsibilities for the animal
- (2) that the animal is acquired at the Acquirer's risk;
- (3) that the Acquirer is responsible for checking that the animal is suitable and meets their expectations;
- (4) that Council makes no warranties about:
 - (a) the suitability or condition of the animal; and
 - (b) the behaviour, temperament and safety of the animal;
- (5) that Council will not be responsible for any maintenance or upkeep of the animal's health or safety after the Acquirer collects the animal;
- (6) by acquiring the animal, the buyer agrees:
 - (a) to treat the animals humanely;
 - (b) and adhere to all relevant legislation including Local Laws, Planning Schemes and biosecurity obligations;
- (7) the Acquirer must collect the animal from:

(8) The Acquirer must collect the animal from the Site at their own cost and must comply with all Queensland Government guidelines for moving horses, including, but not limited to those published at the below:
